
MISSION

CALIFORNIA HIGH-SPEED RAIL

To initiate the construction of a high-speed train system that utilizes an alignment and technology capable of sustained speeds of 200 miles per hour or greater.

Three principles guide our decisions:

- 1. Initiate high-speed rail service in California as soon as possible.
- 2. Make strategic, concurrent investments that will be linked over time and provide mobility, economic and environmental benefits at the earliest possible time.
- Position ourselves to construct additional segments as funding becomes available.





PROJECT SCOPE

CALIFORNIA HIGH-SPEED RAIL

Phase I:

- >> 520 Miles
- San Francisco to Los Angeles/Anaheim

Phase II:

- Extends 300 Miles
- Connections to Sacramento and San Diego

At Least 200 mph

Up to 24 Stations





PROGRAM PROGRESS

CALIFORNIA HIGH-SPEED RAIL

Today:

- 3 199 miles environmentally cleared
- 3 119 miles under construction
- Caltrain electrification construction underway
- Funding committed for LAUS improvements
- » MOU with Brightline West
- Environmentally clearing full 500 miles between LA- SF
- » Station planning





PROGRAM UPDATE

PROGRAM HIGHLIGHTS

- 5,500 + construction jobs created since construction began
 - » 3,700 National Targeted Worker hiring (disadvantaged communities)
- 621 small businesses employed
- CA High-Speed Rail will be 100% electric run on renewable energy
 - » Currently using Tier IV equipment
 - » Will provide mode shift
 - Will reduce VMT (taking 400k cars off the road annually)





CURRENT CONSTRUCTION IN THE CENTRAL VALLEY

CONSTRUCTION PACKAGE 1



- Construction Package 1 (CP 1) is the first construction contract executed on the Initial Operating Section
- Extends 32-miles between Avenue 19 in Madera County to East American Avenue in Fresno County
- 33 Structures: Includes grade separations and viaducts in Fresno & Madera County.
- At-grade station in Downtown Fresno.
- Estimated Completion Date: December 2023



CURRENT CONSTRUCTION IN THE CENTRAL VALLEY

CONSTRUCTION PACKAGE 2-3



- Construction Package 2-3 (CP 2-3) is the second construction contract executed on the Initial Operating Section
- Extends approximately 65 miles from the terminus of Construction Package 1 at East American Avenue in Fresno to one mile north of the Tulare-Kern County line
- 49 Structures: Includes grade separations and viaducts in Fresno, Tulare and Kings counties.
- Elevated Station at Hanford
- Estimated Completion Date: December 2023



CURRENT CONSTRUCTION IN THE CENTRAL VALLEY

CONSTRUCTION PACKAGE 4



- Construction Package 4 (CP 4) is the third construction contract executed on the Initial Operating Section
- 22-mile stretch from approximately one mile north of the Tulare/Kern County Line at the terminus of Construction Package 2-3 to Poplar Avenue just north of the City of Shafter.
- 11 Structures: Includes grade separations and viaducts Kern and Tulare counties.
- Estimated Completion Date: April 2022



PROGRAM DELIVERY SUPPORT CONTRACT

 Performance-based contract with payment at risk is sensible and is consistent with delivery contracts

Term will be 4 years with options to extend

Estimated Cost: \$380 Million for the 4-year term

Key personnel is important



PROGRAM DELIVERY SUPPORT CONTRACT

The Program Delivery Support consultant will be:

- »Responsible for working closely and cooperatively with the Authority's executive leadership, financial consultants and local, state and federal agencies.
- »Responsible for supporting the Authority in managing project delivery consultants including, but not limited to, regional consultants, design consultants, right-of way consultants and environmental consultants.
- »Responsible to provide expertise to the Authority to link program management and construction management to create a singular project controls system that optimizes program management.



PROGRAM DELIVERY SUPPORT CONTRACT

The Authority is seeking a consultant to:

- »Play a lead role in program delivery
- »Enhance accountability through performance measurements
- »Support the Authority future needs such as program delivery, program and project integration, oversight and management of project delivery consultants, HSR systems, operations and maintenance, and alternative delivery models
