Key Topics

- Contractor needs to complete design to start construction at critical locations (approved RFC plans). TPZP recently provided 31 design
 packages which were certified after a Design Quality Audit and are being submitted to the Independent Civil Engineer (ICE) for review
- Parcel acquisition is behind the dates specified in the Right-of-Way Acquisition Plan and continues to be a schedule risk
- The Authority continues to work with TPZP to start construction at other priority locations
- STR12 San Joaquin River Viaduct accident on November 18. An investigation is ongoing by CalOSHA
- Recommended BMPs for Fresno River Viaduct and Cottonwood Creek prior to site closure
- Provided direction to TPZP about potential hazardous materials in soils beneath various parcels
- Provided recommendations for SWPPP BMPs throughout CP-1 in preparation for the rainy season (November 1st)
- Met with State Water Resources Control Board (SWRCB) and Regional Water Quality Control Board (RWQCB) at water crossing sites to inspect SWPPP BMPs

- Formed deck, placed deck reinforcement and placed concrete for frame 3 between bents 7 through 9 (ongoing)
- o Continued to set soffit panels, place reinforcement and concrete for soffit/stem walls on viaduct north of North Avenue (ongoing)
- o Completed falsework erection over North Avenue between bents 21 and 22 (complete)
- o Started setting soffit and stem wall forms, reinforcement installation between bents 21 and 22 (ongoing)
- o Continued large CIDH piles, north of North Avenue (ongoing)
- Continued forming, reinforcement and concrete placement for parapet and derailment protection walls on viaduct north of North Avenue (ongoing)
- o Completed placement of concrete for spans 9 through 11 top decks (complete)
- Completed grouting of post tension ducts for frame 5 (complete)
- Continued to install post tension strands and grouting of post tension ducts for frame 4 between bents 9 through 12 (ongoing)

Muscat Avenue

- Continued grouting post tension ducts (ongoing)
- Started constructing forms for abutment back wall (ongoing)
- Started to form and place concrete for post tension duct box closure pours (ongoing)

American Avenue

- Deficiencies identified at bents 2 and 3 were repaired (complete)
- Continued forming and reinforcement placement for bents 2 and 3 column caps (ongoing)
- ROW and Demo/Abatement
 - o Transferred four (4) parcels in 1A/1B and one (1) parcel in 1D to TPZP authorizing access to the property; five (5) properties were transferred this period (ongoing)
 - One hundred forty-six (146) structures have been remediated, one hundred sixty-six (166) have been demolished (ongoing)
- Four (4) design submittal received an Approval (APP), one (1) design submittal received a Statement of No Objection with Comments (SNOC) and nine (9) design submittals were Rejected With Comments (RWC). Fourteen (14) design submittals remain in review
